



GBS US warrants Angelo PO equipment to be free from defects in material and workmanship:

- For all original equipment manufacturer (OEM) parts, one (1) year from the date of installation of the appliance or fifteen (15) months from the shipping date, whichever occurs first.
- The labor warranty period is one (1) year from the date of installation or fifteen (15) months from the shipping date, whichever occurs first.
- By acquiring and installing and properly maintaining the APRO water filtration system at the time of purchase, you will receive an extended warranty of one (1) year on parts and labor.
- An additional K-12 warranty is available for K-12 schools only and on the condition that the following items are also purchased along with the equipment: Certified Installation, APRO water treatment system, and electric or gas parts kit. The maximum duration of this warranty would be the standard one (1) year plus an additional one (1) year, ensuring extended coverage for the purchased equipment.

Water requirements: Inlet: 3/4", Line Pressure: 30 to 60 psi (2 to 4 bar), PH: 7-8.5, TDS: 40-150ppm

The GBS US warranty is limited to the repair or full replacement of equipment. Equipment will be fully replaced only if GBS US has diagnosed the equipment to be unrepairable.

Warranty repairs must be performed by GBS US authorized service companies only. GBS US will bear normal labor charges performed during standard business hours, excluding overtime, holiday rates, or any additional fees.

GBS US is an authorized warranty, parts, and service agent for Angelo PO.

All service, parts, and shipping must be pre-authorized by GBS US to be covered under this warranty.

This warranty also does not cover product damage occurring as a result of;

- a) improper usage of the product, using it for purposes other than its intended purpose, or failure to observe the GBS US operating and maintenance instructions; in particular, insufficient cleaning and/or maintenance
- b) improper installation or usage of the device in a manner that does not comply with the technical or safety requirements applicable in the country where the device is being used
- c) repair attempts that are unprofessional, do not comply with instructions, or are made by unauthorized third party
- d) third-party influence or force majeure (such as fire or water damage)

It is highly recommended that the Angelo Po reverse osmosis water treatment system (APRO water filter system), be used and incorporated into all Angelo Po Combistar combi oven installations. It is a requirement that GBS US branded cleaning chemicals (FX TDE10 detergent and FX TBR10 sanitizer) are the sole chemical compositions that are utilized for the Angelo Po combi oven. Any non-GBS US branded chemicals utilized will render the warranty null and void. It is the sole responsibility of the owner/operator/purchaser of the Angelo Po equipment, to verify that the incoming water supply is comprehensively tested to meet the Angelo Po water compliance standards, published in this document. Non-compliance with the Angelo Po water standards noted herein could potentially damage the equipment and/or VOID the original manufacturer's standard warranty.
